The following explanations are numbered to correspond to the numbered items on the attached Form:

- (1) <u>Letter of Credit Number</u> This number is to be selected and assigned by the financial institution.
- (2) <u>Date</u> Insert the date this Letter of Credit is signed.
- (3) <u>Name and Address of Issuing Bank</u> Type or print the name and address of the bank issuing the Letter of Credit. This is the address to which the Division of Reclamation will send all correspondence concerning this Letter of Credit.
