INSTRUCTIONS:

- 1. To claim a deduction on a personal property solar power device, the owner should file the Form SES/WPD with the County Auditor of the county in which the property is located.
- 2. In order to verify that the solar power device was reported for taxation on the owner's personal property return, the owner should attach the Form 103-SPD to his original personal property return or his amended personal property return.
- 3. This deduction applies to a solar power device installed after December 31, 2011.
- 4. This schedule must be filed for each year the deduction is being claimed.

NOTE: This deduction is not removed from the assessed value reflected on the personal property return but is determined at a later time by the County Auditor and then deducted from the assessed value before tax statements are mailed.
