SPECIAL REQUIREMENTS

A fee in accordance with 312 IAC 29-4-10(c) is required to transfer permits. The fee amounts are as follows:

- **1-50 Transfers in a single submission = \$15 per application**
- **50 Transfers in a single submission = \$15 per application for the first 50 transfers and \$10 per application for each transfer over 50**
- **If paying by check, please make payment to the Indiana Department of Natural Resources and send the check along with the completed transfer form to the division's address shown at the top of the form.**

1. Please print or type in completing this form and return to the address listed at the top of this form.
2. The new operator must submit a surety, cash, or certificate of deposit bond with this application unless you have a valid blanket bond on file with the division or is exempt from bonding under IC 14-37-6-1.
3. The new operator must submit an Organizational Report with this application unless you have a valid report on file with the division.
4. Only those persons whose names appear in PARTS V or VI of the Organizational Report may sign this form as the operator or new operator. The signatures of both the operator and new operator must appear on this form before a transfer request can be processed.
5. **This form may not be used to transfer permits that have been revoked.** You must submit an Application for Well Permit (Form No. A1) to re-permit a well that has a revoked permit with a well type of Change of Operator.
6. If the new operator is a corporation, limited partnership, or limited liability company, registration with the Indiana Secretary of State is required before a transfer request can be processed. For information regarding registration, you should contact the Corporations Division of the Secretary of State at (317) 232-6576
