TO THE INSPECTOR (or person serving as inspector in a vote center): After the polls are closed, enclose in this envelope the Affidavits (*if any*) listed above that were used on the day of the Election. **NOTE: The PRE-4 challenged voter affidavits are printed directly on the PRO-2 envelope and sealed in the PRO-4 envelope. Securely seal, fill in the spaces above, and have the Inspector and Judge of the opposite political party (or the officials exercising those responsibilities in a vote center) sign and deliver the envelope to the County Election Board with the other returns. If no affidavits are used, return this envelope with your precinct supplies.**

PROCESSING INSTRUCTIONS FOR COUNTY ELECTION BOARD AND PROSECUTING ATTORNEY

The county election board shall: (1) remove the affidavits from this bag or envelope; (2) mail a copy of each affidavit to the secretary of state of Indiana ; (3) replace the affidavits within the bag or envelope; (4) reseal the bags or envelope with the endorsement of the name of each county election board member on the back of the bag or envelope; and (5) carefully preserve the resealed bag or envelope and deliver it, with the county election board seal unbroken, to the foreman of the grand jury when next in session. After the final date and hour for filing a recount or contest and the county election board's canvass of the returns, and after making one (1) copy of each affidavit for the Secretary of State and one (1) copy for the grand jury, the county election board shall forward a copy of each affidavit (other than an affidavit of a person who was unable or refused to supply additional residence documentation, but did so before the close of the polls on election day) to the prosecuting attorney. The prosecuting attorney shall: (1) proceed as if the affidavit had been made before the prosecuting attorney; and (2) ensure that the grand jury notifies the co-directors of the Indiana Election Division is a violation of the National Voter Registration Act appears to have occurred. The prosecuting attorney shall preserve the affidavits and envelopes in accordance with IC 3-10-1-31.1, and shall return the affidavits and envelopes to the circuit court clerk after the prosecuting attorney has completed any proceeding resulting from the investigation of the affidavits and envelopes.
