1. PREFERRED PARKING PROGRAM (PPP)

The Indiana Department of Administration, Parking Services Division is offering State employees preferred parking spaces for coming to work in car-pools.

This is known as the Preferred Parking Program (PPP).

2. EMPLOYEE AND ENVIRONMENTAL BENEFITS

Employee Benefits:

- 1. Savings: Fuel costs and less wear on individual vehicles.
- 2. Parking: car-pooling can reduce congestion in the parking facilities and ease access into and out of the garages.
- 3. Preferred Parking is generally located on first floor of the parking garages with easy access to the main entrance.

Environmental Benefits:

Fewer vehicles mean fewer emissions on No Zone Action Days and less fuel usage with emphasis on energy conservation.

3. HOW TO PARTICIPATE IN PPP

- 1. Check with co-workers who live in your neighborhood or on your way to work. Ask others if they know of any friends or co-workers who live close to you.
- 2. As you contact persons interested in sharing a ride or car-pooling to save energy, aid the environment, and reduce parking congestion, have them complete the information in the participant area of the application on the reverse side.
- 3. When you have two (2) or more names together, send this form to <u>IDOAParkingServices@idoa.in.gov</u>.
- 4. One special reserved hanging tag will be issued per Preferred Parking Car Pool.The permit is valid in the assigned garage only.This tag must be displayed in the car being driven each day in order to park in the reserved parking area.
- 5. Participation in the program does not guarantee preferred parking; space availability is on a first come, first served basis.
