- 4. Out-of-state dealers must also submit (1) a copy of the license for each licensed auctioneer conducting the auction; (2) a copy of the dealer's valid license; and (3) zoning approval.
- 5. A completed application must be received by the Auto Dealer Services Division not later than thirty (30) days before the beginning date of the proposed special event.
