- INSTRUCTIONS:**
1. Complete in blue or black ink or print form.
 2. The certificate of title may only be surrendered if the vehicle or watercraft is not required to be titled but has been titled voluntarily under Indiana Code 9-17-1-1.
 3. For a vehicle or watercraft that is not required to be titled but has been titled voluntarily on or after July 1, 2016, the title must either be (1) re-titled by the subsequent purchaser prior to applying for a registration or (2) surrendered by the titled owner or the subsequent purchaser prior to the subsequent purchaser applying for a registration.
 4. If the person(s) named on the certificate of title is also the person surrendering the certificate of title, all owners named on the certificate of title must either sign this affidavit or have signed off on the certificate of title. When all owners have signed off on the certificate of title, at least one person must sign this affidavit.
 5. If the certificate of title has been surrendered, the current owner or a subsequent purchaser may, at any time, re-apply for a new certificate of title and pay any applicable title fees and/or taxes.
