## **INSTRUCTIONS:**

- 1. Complete in blue or black ink or print form.
- 2. For new purchases, the affidavit must be completed within forty-five (45) days after the vehicle's purchase date.
- 3. For renewal transactions, this affidavit must be completed on or before the expiration date of the existing registration.
- 4. To be valid, this affidavit must also be completed by a license branch associate according to the time requirements in Instructions 2 or 3 as applicable.
- A completed and original affidavit must be retained and resubmitted by the owner upon applying for a certificate of registration, or an administrative penalty will be assessed. Photocopies will not be accepted.

This affidavit may be completed in lieu of a new registration or a renewal registration for a vehicle that will not be used on an Indiana road for a period of at least ninety (90) consecutive days. Upon the timely completion of this affidavit by the registrant and a license branch associate, the vehicle described below is not required to be registered until the registrant intends to use the vehicle upon an Indiana road.

If, at any time after completing this affidavit, the vehicle will be operated on an Indiana road, the owner must apply for a certificate of registration. Upon applying for a certificate of registration:

- If the owner is in compliance with the requirements stated in this affidavit, an administrative penalty will not be charged.
- . If the vehicle has not been registered previously, a registration fee will be due along with taxes back to the date of purchase.
- If the vehicle was previously registered, a registration fee will be due along with taxes back to the date of last registration expiration.
