1. All events are \$2500.00 (IC7.1-3-6-3.8(a)(2)(B)). Business checks or money orders are accepted made out to the Indiana Alcohol and Tobacco Commission.
 2. The permit may be issued for a term up to and including three (3) days.
 3. No rain checks on any of the above events.
 4. The commission may not issue this type of temporary beer permit to any one (1) person more than two (2) times in a calendar year.
 5. Applicant must complete all requested information.

STEP 3. ACKNOWLEDGEMENT

In order to qualify for this authority to serve beer, the following guidelines must be met:

1. There must be a well defined premises enclosed by fencing, barricades, or structures. The area may be an outside area that is contiguous to a brewery described in IC 7.1-3-2-7(5) or restaurant or at another location that is not on or near the premises of a brewery or restaurant.
2. You must have a defined floor plan or diagram that is submitted as an attachment to this application.
3. Attendees of the festival or event may carry beer, in a quantity that does not exceed a total of two hundred eighty-eight (288) ounces, into the permitted area. Beer carried in to a festival or event under this subsection may be consumed or traded only in the permitted area.
4. Attendees of the festival or event may carry out beer in sealed, unopened containers from the temporary beer permit area.
5. No wine or spirits may be served, carried in, or carried out from the festival or event.
6. Each applicant must designate an individual to be responsible for the event and such person shall sign the authority.
7. **ANY** and **ALL** persons dispensing or accepting payment for alcoholic beverages **MUST POSSESS** a valid ATC employee permit.
8. The event must meet applicable Indiana State Board of Health requirements, particularly with regard to restroom facilities.
9. Legal Hours of dispensing alcoholic beverages: (Prevailing time)
Monday through Saturday -- 7 AM to 3 AM the following day
Sunday -- 7 AM to 3 AM the following day
10. **Applicant must file this application with the ATC at least fifteen (15) days prior to the event to guarantee timely processing.**
11. The authority must be posted in the most conspicuous place at the location of the event.

STEP 4. SIGNATURE AND AFFIRMATION

I certify that all information provided herein and on any attachments is true and correct. I understand that it is a felony to misrepresent or falsify any portion of this application or attached documents.

I hereby consent for the duration of the permit term to inspection and search by an enforcement officer, without a warrant or other process, of my licensed premises to determine compliance with the provisions of IC 7.1.
