## Oversize / Overweight Affidavit to Waive Use of Bucket Trucks

Affiant agrees to the following:

- Affiant is at least 18 years of age and has personal knowledge of the facts and statements set forth herein.
- Affiant has the authority to make agreements on behalf of the Transporting Company.
- The Transporting Company will be transporting a load that is over the statutory height of thirteen (13) feet, six (6) inches, which will require the Transporting Company to obtain an oversize / overweight permit from the State.
- The Transporting Company will be transporting a load that is over fifteen (15) feet in height and routed off of an interstate system, which, in addition to obtaining an oversize / overweight permit, will require the Transporting Company to obtain a pre-qualified signal contractor with a bucket truck to accompany the load.
- The Transporting Company has applied for the aforementioned oversize / overweight permit for this load by submitting a completed Form M-233 to the State.
- Affiant requests that the State waive the requirement that the Transporting Company obtain the required pre-qualified signal contractor with a bucket truck to accompany the load.
- In consideration for waiving the aforementioned requirement to obtain a pre-qualified signal contractor with a bucket truck to accompany the load, Affiant agrees that the Transporting Company will indemnify, defend, and hold harmless the State, its agents, officials, and employees from all claims and suits including court costs, attorney's fees, and other expenses caused by any act or omission of the Transporting Company and/or its employees or agents in transporting of this load. Affiant also agrees that the Transporting Company will pay all reasonable expenses and attorney's fees incurred by or imposed on the State in connection herewith in the event that the Transporting Company shall default.
- Affiant acknowledges and agrees that the State shall not provide such indemnification to the Transporting Company, its employees, agents, officials or related parties.
- Affiant acknowledges and agrees that the Transporting Company will follow every law and requirement of the State that is applicable to the transportation of this load, including obtaining the proper number of escorts and that the escorts have height sticks.
- Affiant acknowledges and agrees that the Transporting Company will keep a copy of this Affidavit with a copy of the permit and any required general or special provisions in the vehicle while the load is being transported in Indiana.
- Affiant acknowledges and agrees that the failure to keep a copy of this Affidavit in the Transporting Company's vehicle may subject the Transporting Company and/or its driver to a citation / ticket / fee by a law enforcement agency.
- Affiant further acknowledges and agrees that the State is not responsible for any citation / ticket / fee issued by a law enforcement agency, and any resulting court costs and legal fees, in connection with this load.
- Affiant acknowledges and agrees that this agreement applies only to one permitted load, and that the Transporting Company must submit a new Affidavit and permit request for each load that it requests to have the bucket truck requirement waived.

The undersigned warrants that they are the Affiant, and that they are the authorized representative, agent, member, or responsible officer of the Transporting Company.
