## **SECTION 1 - INFORMATION**

Only a voter with print disabilities may use this combined form to register to vote in Indiana or change your name and address on your registration record or transfer your registration if you move out of your precinct and use it to request an absentee ballot be mailed, emailed, or faxed to you for the calendar year in which you filed this form (January 1 to December 31). A voter with print disabilities is defined in Indiana law as an individual who is unable to independently mark a paper ballot or ballot card due to blindness, low vision, or a physical disability that impairs manual dexterity.

To register to vote in Indiana you must: Be a citizen of the United States; be at least 18 years old on the day of the next general or municipal election; have lived in your precinct for at least 30 days before the next election; and not currently be imprisoned after being convicted of a crime.

If you are registering to vote in Indiana for the first time, you are required to provide additional residence documentation before voting. If the county is able to match your driver's license number or social security number with an existing Indiana identification record bearing the same number, name, and date of birth you provide on the application, you have met the requirement. You can also meet this requirement by submitting proof of residence with this application or anytime up until election day. Proof of residence can be met by submitting either: (1) a COPY of your current and valid photo identification or (2) a current utility bill, bank statement, government check, paycheck, or government document that shows your name and address at the address you provided on this application. Please do not send originals. Cover any account information with a permanent marker.

## **SECTION 2 – DETAILS REGARDING THE VOTER REGISTRATON PORTION OF THIS FORM**

You will be sent a notice from your county voter registration office acknowledging receipt of your voter registration application. The notice informs you whether your application to register to vote was approved by the county voter registration office. If your application is incomplete, you will be asked to provide additional information. If you do not receive a notice within 30 days of filing this application, contact your county voter registration office.

**Voter Registration Deadline:** This application must be postmarked or delivered to your county voter registration office not later than 29-days before the next election. If you miss this deadline, your application will be processed when registration reopens.

### SECTION 3 – DETAILS REGARDING THE ABSENTEE APPLICATION PORTION OF THIS FORM

The county election board is required to provide notice to you if your request for an absentee ballot has been denied. Please note that the first mailing of absentee ballots to voters occurs approximately 45-days before each election. You can track the date your absentee ballot was mailed by logging in to [indianavoters.com](http://indianavoters.com).

Indiana Code 3-11-4-2 requires you to provide your 1) Indiana driver's license number, 2) Indiana identification card number, 3) the unique identifier assigned to your voter registration record, or 4) the last 4 digits of your social security number if you wish to vote absentee by mail, fax, or email. You are only required to provide one of these numbers. Alternatively, you may provide a photocopy of your valid Indiana driver's license, Indiana ID card, or other proof of identification under IC 3-5-2-40.5. Your absentee ballot application may be delayed if the county election board cannot match at least one of the voter identification numbers with your voter registration record or you do not enclose a photocopy of your valid photo ID. Information provided in this section of the absentee ballot application is confidential. A county is required to redact this information when responding to a public records request.

**Absentee Application Deadline:** To be used to request an absentee ballot by mail, fax, or email, this form must be received not later than 11:59 PM, 12-days before Election Day. If you miss this deadline, your application for absentee ballot will be processed if there is another eligible election before December 31 of the same calendar year.

**Absentee Ballot Deadline:** When voting by mail, your absentee ballot must be received by the county election board not later than 6:00 PM on Election Day. When voting by fax or email, the completed ballot and the ABS-25 secrecy waiver must be received by the county election board not later than 6:00 PM on Election Day. If you miss this deadline, your absentee ballot will not be counted.

I swear or affirm that:

- I am authorized to use this combined form as I am a voter with print disabilities, which is defined as an individual who is unable to independently mark a paper ballot or ballot card due to blindness, low vision, or a physical disability that impairs manual dexterity.
- I am a citizen of the United States.
- I will be at least 18 years of age at the next general or municipal election.
- I will have lived in my precinct for at least 30 days before the next election.
- I am not currently in prison after being convicted of a crime.
- All the above information and all other statements on this form are true.

If I am requesting an absentee ballot, I understand that:

- I must personally mark my own ballot and if I need assistance with completing the ballot, then I must vote before an absentee voter board or on Election Day.
- If I am requesting an absentee ballot by fax or email, that I am waiving my right to secret ballot and must return a secrecy waiver provided by the county with my completed ballot.
- This request for an absentee ballot is valid for one calendar year (January 1 to December 31) unless I cancel my registration or request an absentee ballot using a different state form.
- I understand the information provided in Section 6, line 16 regarding voter identification for purposes of voting absentee is confidential and, if the number is not on your registration record, you are authorizing the county voter registration official to add it to my record.

I understand signing this form authorizes my voter registration at any other address other than the residence address noted above to be canceled. I understand that if I sign this statement knowing that it is not true then I am committing perjury and can be fined up to \$10,000, jailed for up to two and one half years or both.

## SECTION 11 - APPLICANT'S RECEIPT FROM INDIVIDUAL ACCEPTING CUSTODY OF A COMPLETED VOTER REGISTRATION FORM

If an individual other than the voter takes custody of this combined form to deliver to the Indiana Election Division or county voter registration office, then the individual must complete this affidavit and provide it to the voter pursuant to state law. This is not a receipt that the individual is confirmed to have registered to vote. Instead, it provides the voter with contact information of the person collecting this form on their behalf should the form not be timely delivered to the county or state election offices.

This receipt is not necessary if a member of the voter's household delivers this combined form on behalf of the voter (IC 3-11-4-2); however, any person other than the voter delivering this application to a county office is to complete the ABS-19 affidavit to affirm delivery of the absentee application to the county.

If you accepted a completed form from another person, in order to submit his or her registration for consideration, you must submit the completed form to the county voter registration office or Indiana Election Division not later than noon (local prevailing time), ten days after receipt OR the applicable voter registration deadline, whichever comes first. This receipt must be provided to the applicant. You must also complete the "Third Party Certificate of Acceptance" portion of the application before filing the application.

## SECTION 12 – INSTRUCTIONS FOR COMPLETING THIS FORM

### Personal Information Section (Section 4)

Questions 1 and 2 are required fields. If you check "no" in response to either question 1 or 2, do not complete this application. You are not eligible to register to vote in Indiana.

Question 3 is a required fields. This section asks you for your first name, middle name (or initial), last name, and any suffix. This information will be used on your voter registration record and be used to locate your registration record to process the form as the voter's absentee application.

Question 4 is a required field. Please provide your date of birth in the format of two-digit month, two-digit day, and four-digit year. This information will be included on your registration record and used for processing your absentee application.

Question 5 is optional, as it asks for the Indiana county in which you live.

Question 6 is a required field. You must include the residence address of where you live. If your address is a rural route, include the box number. If your residence has no address or street number, attach a short description of its location or attach a map. Do NOT use a PO Box for your residence address.

Questions 7, 8, and 9 are optional.

### **Voter Registration Information Section (Section 5)**

Question 10 is a required field asking for your Voter Identification Number. You are required to provide your Indiana driver's license number, state ID number, or learner's permit number as issued by the Indiana Bureau of Motor Vehicles. If you do not have an Indiana driver's license, state ID, or learner's permit number, provide the last four digits of your social security number. If you do not have an Indiana driver's license, state ID, or learner's permit number, or a social security number, you must indicate "None" on this line.

Question 11 is optional. A voter can provide their mailing address where the individual would like correspondence related to their voter registration record to be mailed.

Question 12 is optional. If you have been registered to vote at a previous address that is not the same as the residence address entered in question 6, please provide that information, if possible.

Question 13 is optional. If you were previously registered to vote under a different name that is not the same as the names used in question 3, please provide that information, if possible.

### **Absentee Balloting Information Section (Section 6)**

Question 14 is required to receive an absentee ballot. Voters with print disabilities can request their absentee ballot to be mailed, faxed, or emailed to the voter. Subsequently, the voter will need to provide either their mailing address, fax number, or email address in the designated space.

Question 15 is used for absentee balloting requests in the May primary election. To receive a Democratic OR Republican ballot in the primary election, the voter must indicate their party preference here. This is NOT used to register you as a member of a party; instead, it gives direction to the county election board about which party's ballot you would like to nominate candidates at the May primary election. Alternatively, a voter may request a non-partisan ballot for the May primary, which will include any public question that may be certified to the county. Please note: This is not used for voter registration purposes. The choice here gives direction to the county election board about which party's primary you would like to participate in. If a voter does not make a party selection, then no absentee ballot for the May primary ballot will be sent to the voter, assuming this combined form is received by the absentee deadlines for the May election.

Question 16 is a required field. To process your absentee application, you must provide a voter identification number that can be validated against their Indiana voter's registration or provide photocopy of your valid Indiana driver's license, Indiana identification card, or other proof of identification that complies with the state's photo ID law (IC 3-5-2-40.5).

Question 16A prompts voters to provide their Indiana driver's license number, their Indiana identification card number, the unique identifying number assigned to the voter's registration record, or the last four digits of the voter's Social Security number. You may include only one of these numbers, but your application may be delayed if the county election board cannot match at least one of the numbers with your voter registration record.

Question 16B prompts the voter to enclose a photocopy of voter's ID. More information about accepted forms of voter IDs can be found online at [www.in.gov/sos/elections/voter-information/photo-id-law](http://www.in.gov/sos/elections/voter-information/photo-id-law). If you choose this option, your application may be delayed if you do not provide a photocopy of your valid ID. The information provided by the voter in this section is confidential. A county is required to redact this information in responding to a public records request.

If you are unable to sign this application due to disability, then the person who wrote your name on the signature line must complete this section.

**Third Party Certificate of Acceptance (Section 9)**

If you do not personally file this application with the county voter registration office or the Indiana Election Division, the person who accepts custody of the application must complete this certification before filing the application with the county voter registration office or the Indiana Election Division by noon 10-days after receipt or the registration deadline or absentee application deadline, whichever occurs first.
