INSTRUCTIONS For use by the Libertarian Party State Central Committee for filling ballot vacancies for local office. For a ballot vacancy filled under IC 3-13-1-20, this certificate must be filed with the circuit court clerk not later than NOON three (3) days (excluding Saturdays and Sundays) after selection of the candidate. However, when a vacancy occurs because no candidate was nominated at the county or local party convention under IC 3-10-2-15 or 3-10-6-12, the certificate must be filed no later than NOON, July 3, 2024. For a ballot vacancy filled under IC 3-13-2-12, this certificate must be filed with the circuit court clerk not more than three (3) days (excluding Saturdays and Sundays) after selection of the candidate. Candidates for non-judicial local office must attach to this form the candidate's statement of economic interests form (CAN-12). Note: Candidates for city or town judge must attach to this form a receipt showing the statement of economic interests form prescribed by the Commission on Judicial Qualifications was filed. NOTE: The Libertarian State Party Chair must use the CAN-33 form to certify the selection of candidates for judicial office, such as circuit, superior, and probate court judge, and prosecuting attorney, to the Indiana Election Division.

If a candidate's name does not comply with IC 3-5-7, the certification may be challenged under Indiana Code 3-8-1-2. A candidate may use a nickname on the ballot only if the nickname is a name by which the candidate is commonly known and does not exceed 20 characters. A candidate may not use a title or degree as a designation or a designation that implies a title or degree. Nicknames are required to be printed on the ballot using parentheses. EXAMPLE: John R. CAMPAIGN FINANCE NOTICE						
A candidate who fills a ballot vacancy thirty (30) days or more before the general election must file campaign finance reports in accordance with IC 3-9-5- 8.5. A candidate who fills a ballot vacancy less than thirty (30) days before the general election must file campaign finance reports in accordance with IC 3-9-5- 8.5. In addition to all other reports required by IC 3-9-5.						
The candidate's committee must also file a pre-election supplemental report no later than forty-eight (48) hours after the committee receives and accepts contributions from a person that total \$1,000 or more during the period beginning October 12, 2024, and ending November 3, 2024, with the Indiana Election Division, appropriate county election board, or both. If no such contribution is received and accepted, the candidate's committee is not required to file a supplemental report.						
A person who fails to file a report with the Indiana Election Division or a county election board is subject to a civil penalty of \$50 for each day the report is late, with the afternoon of the final date for filing the report being calculated as the first day, for a maximum penalty of not more than \$1,000, plus any investigative costs incurred and documented by the Election Division or county election board.
