The undersigned, desiring to domesticate an Indiana entity into a foreign jurisdiction pursuant to the provisions of Indiana Code 23-0.6-5, executes the following Articles of Domestication.

#### **ARTICLE I – NAME AND JURISDICTION OF ENTITY**

SECTION 1: Name of the entity

a. The name of the entity immediately before filing these Articles of Domestication

b. The name of the entity immediately after filing these Articles of Domestication

SECTION 2: Entity type (*Example: corporation, limited liability company, etc.*) The entity type of the domesticating entity
