1. Complete electronically, or if printed, use blue or black ink.
  2. Submit the completed form to the Auto Dealer Services Division by e-mail to [dealers@sos.in.gov](mailto:dealers@sos.in.gov).
  3. Stolen dealer license plates must be reported to law enforcement and Section D must be completed by that law enforcement agency.
  4. Damaged dealer license plates must be returned to the Auto Dealer Services Division before a replacement dealer license plate may be issued.
  5. The replacement dealer license plate or registration will become the current and only valid plate upon issuance. If found, the lost or stolen dealer license plate is not valid and must be returned to the Auto Dealer Services Division.
