## INSTRUCTIONS FOR COMPLETING FORM SB-2 SURETY BOND RIDER

This form may only be used for bonding permanent program permits issued in accordance with IC 14-34 and IC 14-36-1. Do not make any entries in the space identified "FOR OFFICIAL USE".

The following are explanations of the information that should be entered on the Form SB-2 Surety Bond Rider:

- (1) <u>Bond Number</u> This number is to be selected and assigned by the surety.
- (2) Date Insert the date the original bond was executed.
- (3) <u>Name of Surety</u> Type or print the name of the surety as used on the original surety bond.
- (4) <u>Name of Permittee</u> Type or print the name of the permittee as used on the original surety bond.
- (5) Permit Number Type or print the number of the permit as used on the original bond.
- (6) Pit Name Type or print the name of the mine as used on the original bond.

## PLACE AN "X" IN EITHER BOX 1 OR BOX 2 TO INDICATE THE SECTION THAT IS APPLICABLE.

- (7) <u>BOX 1</u> This section is to be used only to increase or decrease the current amount of bond. Select your choice by checking the box for "increased" or "decreased".
  - (7a) Type or print in words the amount by which the bond is to be increased or decreased.
  - (7b) Type or print in numerals the amount in 7a.
  - (7c) Type or print in words the previous amount of the bond.
  - (7d) Type or print in numerals the amount in 7c.
  - (7e) Type or print in words the new total amount of the bond.
  - (7f) Type or print in numerals the amount in 7e.
  - (7g) Type the date in which the change is executed.
- (8) BOX 2 Check the "Other" box if Box 1 does not apply.
- (9) <u>Date</u> Type or print the date on which the bond is executed.

Items (10) through (18) are to be completed as follows:

- (10) through (13) are to be completed on behalf of the principal.
- (14) through (16) are to be completed on behalf of the surety.
- (17) is to be signed by a person witnessing the signature on behalf of the principal, and
- (18) is to be signed by a person witnessing the signature on behalf of the surety.

Please be sure to submit one (1) original of the fully executed document and one (1) copy.

Upon acceptance of the document, one (1) copy will be returned to the surety, and one (1) copy will be sent to the principal.
