
DISTRICT FORESTER OFFICES

District Foresters are professionally trained foresters employed, by the Indiana Department of Natural Resources' Division of Forestry, to assist private forest owners with the management of their forestlands. This is accomplished through the administration of incentive programs such as the Classified Forest program and cost share assistance programs to implement forest stewardship practices. District Foresters also provide professional technical advice on timber harvesting, tree planting and other forest management activities. IMPORTANT INFORMATION 2025-2026 SEASON

Any individual may purchase seedlings as long as that person agrees to plant them in Indiana for conservation plantings as stated in the Nursery Program mission statement. Plant materials cannot be redistributed or resold for profit. If seedlings produced by our nurseries are to be given away, the buyer must conduct an educational program stating the Nursery Program mission prior to distribution of the seedlings. If you are consulting with a forester or tree planter, please be sure that only one order is submitted.

Orders will be accepted <u>Oct. 1, 2025 - May 1, 2026</u> (depending upon inventory) for standard spring pickup. Telephone, fax and mail orders are accepted (no e-mail orders, please). You do not need a credit card to submit an order.

In-person orders may be placed at either nursery during normal business hours. Business hours are Monday–Friday 8 a.m. to 4 p.m. at each nursery in its local time zone. We are closed on all State-observed holidays.

Order seedlings online starting October 1, 2025 at www.INForestryX.com.

- 2. Do not send payment with your order. You will receive an invoice showing amount due and the due date. We accept most major credit cards, personal checks, cash and money orders. Credit card payments can be made by telephone. Please do not send cash through the mail. There is a \$27.50 returned-check fee. This fee amount is subject to change.
- 3. Orders will be canceled if not paid by the due date on the invoice.
- 4. There is a \$10 (nonrefundable) order processing fee for each order.

 (Do not submit with order. This charge will be added to each invoice upon fulfillment of order.)

- 5. For commercial shipping, the charge is \$50 per 100 seedlings, 50 select line seedlings or one packet. We cannot guarantee delivery by a specific date if shipped by FedEx.
- 6. March 1 is the last day to cancel an order and receive a refund.
- 7. **April 1 is the deadline to change shipping** method or nursery pickup location.
- 8. Shipping season runs from late February-May depending upon the weather. Shipping starts in the southern counties first and moves north as the weather warms. You will receive a postcard when your order is ready for pickup or is being shipped by FedEx. If you need your order prior to receiving the postcard, call the nursery that will be handling your order (see bottom of invoice for nursery). After-hour and holiday pickup is available (call for further details). Those with large orders should call ahead to help with order preparation.
- 9. Our Select line of seedlings: Black Walnut, Red Oak, White Oak and Black Cherry seedlings come from our top-performing seed orchard trees. The parent trees have been selected for their superior growth and form characteristics. Hybrid Butternut seedlings are a naturally occurring hybrid between Native Butternut and Japanese Walnut. These trees have many of the characteristics of Native "Pure" Butternut, in growth, form and nut production but appear to have a much higher level of resistance to Butternut canker.

HELPFUL TIPS

Information concerning the mature size and recommended use of these species can be obtained by contacting either nursery or from the "Tree Species Information" on our website at on.IN.gov/forestry.

Seedling height varies with age and species.

The following is a general guide:

- 3 year old conifer seedlings: 6-20 inches
- 1 & 2 year old conifer seedlings 4-12 inches
- 1 year old deciduous seedlings/select line: 6-20 inches
- 2 year old deciduous seedlings: 8-30 inches
- 1 & 2 year old deciduous small trees & shrubs: 4-20 inches
