## *Definitions & Requirements for Foals of 2019:*

**Indiana Sired & Bred (ISB):** A foal sired by a registered Indiana stallion and from a mare which resides in the State of Indiana continuously from August 1st of the breeding season year through the time of foaling and thirty (30) days after and is properly registered with the IHRC.

- An ISB Foal must be sired by a registered stallion and foaled in the State of Indiana.
- An ISB Foal does not have to be owned by a resident of Indiana.

**Indiana Sired (IS):** A foal sired by a stallion standing in Indiana and registered with the Indiana Horse Racing Commission the year the foal was conceived.

- The mare of an IS foal does not have to reside in the State of Indiana and can be bred by shipped semen.
- An IS foal does not have to be foaled in the State of Indiana.
- An IS foal does not have to be owned by a resident of Indiana.

**Please note that in order for your foal to be considered Indiana Sired & Bred (ISB) the foal must also be registered with the IHRC within thirty (30) days of foaling. Late registrations will only be accepted up until December 31st of the foal's weanling year. A \$200 late registration fee is also required for foals registered after the thirty (30) day deadline.**
