Promoter agrees to make no deduction from the purse monies to be paid to a Fighter unless Fighter agrees to such a deduction, and only if such a deduction is itemized as an addendum to this contract.

Should Fighter desire Manager to be paid directly by Promoter, Fighter must initial here \_\_\_\_\_, and the Manager must be currently licensed in the State of Indiana.

In the event the bout in which the Fighter is scheduled to participate does not occur, due to a non appearance of the Fighter's opponent, the inability of the Fighter's opponent to make the Commission's medical requirements, the inability of the Fighter's opponent to get licensed, or the inability of the Fighter's opponent to make the contracted weight, the Promoter agrees to pay the Fighter a total of  $\frac{1}{(Amount of Purse to be Paid)}$ .

Fighter or Manager may not be entitled to the compensation described above or any part thereof if an official of the Commission decides that Fighter and Manager, or either of them: 1.) Did not enter into the contract in good faith or had any collusive understanding or agreement regarding the termination of the bout, 2.) Fighter did not give a good faith exhibition of his/her skills, 3.) Fighter and/or Manager has violated any of the laws, rules or regulations administered by the Commission.

Promoter shall pay to the Commission any compensation to be forfeited under the terms of the preceding paragraph. To the extent authorized under state law, the Commission shall thereupon dispose of said compensation in accordance with applicable statutes and regulations including, but not limited to: 1.) Forfeiture to the Commission, or 2.) Payment of all or a portion thereof to Fighter or Manager, minus any statutory/regulatory penalties. All parties agree to accept, and to be bound by, the decision of the Commission which shall be final.

It is understood and agreed that the rights and obligations of the parties hereto shall be governed by, and construed according to the laws of the State of Indiana. The terms of this agreement shall, in all respects, be in conformity with the laws of the State of Indiana, as well as the rules and regulations now, or hereafter, adopted by its Commission.

The Fighter understands by participating in a bout of mixed martial arts, that the Fighter is engaging in an abnormally dangerous activity. The Fighter further understands that this participation subjects the Fighter to a risk of severe injury or death. The Fighter, with full knowledge of this risk, nonetheless, agrees to enter into this agreement and hereby waives any claim that the Fighter or Fighter's heirs may have against the Commission and/or the State of Indiana as the result of any injury the Fighter may suffer as a result of Fighter's participation in any bout of mixed martial arts.

INITIALS OF FIGHTER:

The parties, jointly and severally hereby indemnify and hold harmless the State of Indiana and the Commission, and each of their members, agents, and employees in their individual, personal and representative capacities against any and all claims, suits and actions, brought against the persons named in this paragraph by reason of this agreement and all other matters relating thereto, and against any and all expenses, damages, charges and costs, including court costs and attorney fees which may be incurred by the persons and entities named in this paragraph as a result of said claims, suits and actions.

If Promoter or Fighter breaches this contract, the non-breaching party shall have all remedies available at law or in equity.

Promoter and Fighter agree to fulfill, in good faith, the terms and conditions of this contract during the period covered by this contract. It is understood and agreed that if the Fighter enters into another bout prior to this bout and lessens his/her value, the Promoter shall have the option of modifying or canceling this contract. The Commission reserves the right to take any disciplinary action against the Fighter.

The Promoter is responsible for and shall make all the necessary arrangements in accordance with Commission rules/regulations for said bout.
