



# APPLICATION FOR INITIAL LICENSURE OR RENEWAL OF LICENSURE AS A MIXED MARTIAL ARTS PROMOTER

- INSTRUCTIONS:**
1. Any individual or company who wishes to promote a mixed martial arts event must first obtain a license as a mixed martial arts promoter from the Commission.
  2. A mixed martial arts promoter license is an annual license that expires on September 30 of each year, regardless of the date of issuance.
  3. The following information is required to be submitted in order to be issued an **initial** mixed martial arts promoter license:
    - (A) Completed Application for Initial Licensure or Renewal of Licensure as a Mixed Martial Arts Promoter.
    - (B) Clear photocopies of current government issued photographic identification cards (i.e. driver's license, passport) of the principal owner, all substantial owners, and all key persons of the company.
    - (C) A digital photograph of the principal owner, all substantial owners, and all key persons of the company, which shows head and shoulders only, without a hat, and in a natural pose. Please email the digital photograph(s) to [iac@igc.in.gov](mailto:iac@igc.in.gov) and include the name in the subject line.
    - (D) The following Exhibits:
      - Exhibit 1:** A list of any other names under which the individual or company has operated in the promotion of mixed martial arts or boxing events in Indiana or any other state, country, or tribal nation.
      - Exhibit 2:** A list of any mixed martial arts or boxing promoter licenses held, whether active or inactive, in any other state, country, or tribal nation.
      - Exhibit 3:** A list of all previous mixed martial arts events the applicant has promoted in Indiana, including the date and location of the events.
      - Exhibit 4:** For applicants who will be promoting professional events or pro-am events, a surety bond in an amount no less than ten thousand dollars (\$10,000) on the form prescribed by the Commission.
      - Exhibit 5:** Proof of good standing in the applicant's state of incorporation.
      - Exhibit 6(a):** A current corporate structure organizational chart.
      - Exhibit 6(b):** A current personnel organizational chart.
      - Exhibit 7:** A criminal history background check conducted by the Federal Bureau of Investigation of the principal owner, all substantial owners, and all key persons of the company. (The guidelines and necessary paperwork for this process can be found on the Commission's website. Applicants are advised that pursuant to IC 4-33-4-18, all fingerprints provided by applicants will be forwarded to the Federal Bureau of Investigation for a complete national criminal history check. Applicants will have the opportunity to disprove the information contained in the criminal history return. Corrections or updates to the criminal history return may be pursued by following the procedures contained in Title 28, C.F.R., § 16.34.)

The applicant is under a continuing duty to maintain suitability to be licensed as a mixed martial arts promoter and must update the Commission of any changes to company information including arrests, charges, or indictments. Failure to report any arrest, detention, charge, indictment, or conviction that has not been expunged or sealed by a court whether a misdemeanor or felony, is cause for denial of licensure, revocation of the license, or disciplinary action against the applicant.

5. Exhibit 7 above, only when requested by the Commission.
6. A completed and signed application.
