INSTRUCTIONS:

- 1. A professional boxer license is a biennial license that expires on September 30 of each even numbered year, regardless of the
- 2. The following information is required to be submitted in order to be issued a professional boxer license:
 - (A) Application for Initial Licensure or Renewal of Licensure as a Professional Boxer.
 - (B) A clear photocopy of the applicant's active Federal ID card.
 - **(C)** A written statement from a physician, not more than one (1) year old from the date of the event in which the applicant seeks to participate, which affirms that the applicant has undergone a thorough medical examination and is physically fit and qualified to participate in the sport of boxing. The physician who conducts the medical examination and affirms the physical fitness of the applicant must have been licensed in the jurisdiction in which the medical examination occurred at the time the medical examination was conducted. The physical must be done on a form prescribed by the Commission or the Commission of another state, country, or tribal nation.
 - **(D)** Laboratory results, not more than one (1) year old from the date of the event in which the applicant seeks to participate, affirming that the applicant has tested negative for the presence of:
 - (1) antibodies to the human immunodeficiency virus (HIV),
 - (2) the surface antigen of the hepatitis B virus, and
 - (3) antibodies to the hepatitis C virus.
 - (E) One (1) digital photograph of the applicant which shows head and shoulders only, without a hat, and in a natural pose. Please email the digital photograph to iac@igc.in.gov and include your name in the subject line.
- **3.** The license fee for this application is \$50.00 and is nonrefundable. Checks and money orders should be made payable to the Indiana Gaming Commission. Please mail, along with the necessary information above, to:

4. The applicant is under a continuing duty to maintain suitability to be licensed as a professional boxer and must update the Commission of any material changes to the information provided on this application. Failure to update the Commission of any changes may result in denial of the application or disciplinary action against the applicant.
