| | Each home that has child care provided on the first story is required to have two (2) exits on that story. These exits must be separated from each other by a distance that is equal to not less than one-half (1/2) the largest diagonal dimension of that story. | |
| | An areas used for child care must be located not more than seventy-five (75) feet from approved exit. | |
| | Only one (1) exit may pass through an intervening room so long as the intervening room is not a kitchen, bathroom, closet, storage area, or any room where hazardous materials are stored. At least one (1) exit shall exit directly to the exterior of the residence. If the only exit from a room is through an allowed intervening room, there must be smoke detectors in both rooms. | |
| | Smoke alarms must be hard wired to the home's electrical system and wired in such a manner that activates all of the smoke detectors in the home when anyone (1) detector is activated. Detectors must be audible throughout the home. | |
| | Smoke alarms shall be installed according to the manufacturer's installation guidelines. | |

| | Provide all child care services on the first story of the child care home unless the Class II child care home meets the following conditions: (1) Home is equipped with an automatic sprinkler system throughout (including basement area). (2) There are at least two (2) exits directly to the exterior of the home for the sole use of the occupants of the second story. (3) No children under twenty-four (24) months of age on the second story. | |
| | A two and one-half (2-1/2) pound or greater ABC multiple purpose fire extinguisher is required in each room used for child care. | |
| | There are thirty-five (35) square feet of usable play space per child. Hallways, bathrooms, cooking surfaces, utility rooms, closets, and areas not used for care are not measured. | |

Rule 1.3. Class II Child Care Homes

470 IAC 3-1.3-1 Class II child care home services

Authority: IC 12-13-5-3 Affected: IC 12-17.2-5-6.5

Sec. 1. A Class II child care home serves more than twelve (12) children but not more than sixteen (16) full-time and part-time children at anyone (1) time. A licensee who provides Class 11 child care shall meet all the requirements of 470 IAC 3-1.1 and 470 IAC 3-1.2 as well as the requirements of this rule. If there is any difference in requirements, the specific information contained in IC 12-17.2-5-6.5 shall prevail.

470 IAC 3-1.1-7 "Child care home" defined

Authority: IC 12-13-5-3 Affected: IC 12-17.2

- Sec. 7. (a) As used in this rule, "child care home" means a residential structure in which at least six (6) children (not including the children for whom the provider is a parent, stepparent, guardian, custodian, or other relative) at any time receive child care from a provider:
 - (1) while unattended by a parent, legal guardian, or custodian;
 - (2) for regular compensation; and
 - (3) for more than four (4) hours but less than twenty-four (24) hours in each of ten (10) consecutive days per year, excluding intervening Saturdays, Sundays, and holidays. The term does not include a child care center.
 - (b) The term includes the following:
 - (1) A Class I child care home.
 - (2) A Class II child care home.

Qualification for licensure of class II child care home

- Sec. 6.5. (a) To qualify for a license to operate a class II child care home under this chapter, a person must do the following:
 - (1) Provide all child care services on the first story of the child care home unless the class II child care home meets the exceptions to the first story requirements contained in the Indiana building code adopted by the fire prevention and building safety commission in effect at the time the class II child care home provider applies for licensure.
 - (2) Provide a smoke detection system that is:
 - (A) hard wired to the building's electrical system; and
 - (B) wired in a manner that activates all of the detector devices in the building when one (1) detector device is activated.
 - (3) Provide a fire extinguisher in each room that is used to provide child care services.
 - (4) Meet:
 - (A) the exit requirements for an E-3 building occupancy classification under the Indiana building code adopted by the fire prevention and building safety commission, except for any illumination requirements, in effect at the time the class 11 child care home provider initially applies for licensure; and
 - (B) the illumination requirements established in section 6.3(b)(2)(O) of this chapter.
 - (5) Provide a minimum of thirty-five (35) square feet for each child.
 - (6) Conduct fire drills required under article 37 of the Indiana fire prevention code adopted by the fire prevention and building safety commission in effect at the time the class II child care home provider applies for licensure.
 - (7) Apply for a license before July 1, 1996, or after June 30. 2001.
 - (8) Comply with rules adopted by the division of family and children for class II child care homes.
 - (9) Complete the training course taught or approved by the division concerning safe sleeping practices for a child within the person's care as described in IC 12-17.2-2-1(10).
 - (b) To qualify for a license to operate a class 11 child care home under this chapter, a person, before applying for the license, must have:
 - (1) a class I child care home license; or
 - (2) at least one (1) year of experience as a caregiver in a child care home or child care center.

FIRE SAFETY, BUILDING, AND EQUIPMENT LAWS: GENERAL ADMINISTRATION

IC 22-12-1-5

"Class 2 structure"

- Sec. 5. (a) "Class 2 structure" means any part of the following:
 - (1) A building or structure that is intended to contain or contains only one (1) dwelling unit or two (2) dwelling units unless any part of the building or structure is regularly used as a Class 1 structure.
 - (2) An outbuilding for a structure described in subdivision (1), such as a garage, barn, or family swimming pool, unless any part of the outbuilding is regularly used as a Class 1 structure.
 - (b) Subsection (a) does not include a vehicular bridge.
