- You are currently receiving assistance as a TANF recipient.
- You formerly received TANF assistance for a child for whom paternity has not been established, and for whom the establishment of paternity and an order for child support can still be obtained.
- You are currently receiving Medicaid Assistance which began after July, 2000 for a child for whom paternity has not been established, and / or for whom there is not an order requiring the provision of health insurance from the noncustodial parent.

IF NONE OF THE ABOVE CRITERIA APPLY AND YOU WISH TO HAVE YOUR CASE CLOSED:

- You will not be entitled to receive any support enforcement services from the prosecutor's child support office. These
 include paternity establishment, parent locator, establishment and enforcement of support orders, income withholding
 orders, and tax refund offsets.
- If your case was previously a public assistance case (AFDC / TANF), the state will process support payments and tax offsets in accordance with the applicable federal and state IV-D law governing the distribution of collections.
- To assure timely delivery of support payments to which you are entitled, you must notify the Clerk of the Circuit Court where support payments are collected for this case of any change of your address.
- If you become a TANF recipient in the future, you will again be referred to the IV-D program, and your participation and cooperation will be required.
- If you wish to receive IV-D child support services in the future as a non-TANF case, you will be required to pay the required application fee.
