NOTE OF CONFIDENTIALITY OF INFORMATION

To the extent feasible and permissible by law, the Indiana Economic Development Corporation (IEDC) will honor an applicant's request that confidential information submitted to the IEDC remains confidential. The IEDC will treat information as confidential only if: (i) the information is in fact protected confidential information such as trade secrets or privileged or confidential commercial or financial information, (ii) the information is specifically marked and identified as confidential by the applicant, (iii) the information is segregated and placed in a separate appendix to the application, and (iv) no disclosure of the information is required by law or judicial order. If the application results in a tax credit authorization, the honoring of the confidentiality of the identified data shall not limit the IEDC's right to disclose the details and results of the economic development project to the public.

The Media Production Expenditure Tax Credit may not be used in combination with the Qualified Media Production Gross Sales Tax Exemption, Lodging Tax Exemption, or any other Indiana Tax Credit.

In order to be considered for the Qualified Media Production Expenditure Tax Credit, the taxpayer must spend a minimum of one hundred thousand dollars (\$100,000) towards the production of a feature length film, short film, documentary, or television series, program or feature. A taxpayer seeking the credit for a digital media production that is intended for reasonable commercial exploitation, an audio recording or music video, an advertising message broadcast on radio or television, or a media production concerning training or external marketing or communications must spend at least fifty thousand dollars (\$50,000) towards the production. Eligible expenses may include pre-production, production, and post-production expenses.
