This certificate must be filed with the circuit court clerk no later than three (3) days (excluding Saturdays and Sundays) after selection of the candidate. However, when a vacancy occurs because no candidate was nominated at the primary, the certificate must be filed not later than NOON, July 3, 2023. Except for city and town judge candidates, a CAN-12 statement of economic interests by the candidate selected to fill the early ballot vacancy for a city or town office must be filed WITH this form. A candidate for city and town judge must attach to this form a receipt showing the statement of economic interests form prescribed by the Commission on Judicial Qualifications was filed.
